## WHERE CAN I RIDE MY SCOOTER?


Hey is that minibike supposed to be running down the sidewalk? Is that ATV buzzing down the street supposed to be there? There has been a lot of questions regarding the operation of scooters, mopeds, golf carts and atvs within the neighborhood. What can I ride on the street and where is that definition in the Lincoln Municipal Code?

At the September Arnold Heights Neighborhood Association meeting Police Captain Travis Banks shared with us a handout listing operating specifics for various types of motorized vehicles. We felt it pertinent to share this with the grater community and you will see it on the 2<sup>nd</sup> page of this newsletter.

Can I drive my golf cart on the street? Yes, but only between sunrise and sunset, I didn't know that. An electric scooter can be classified two ways, if it is a personal use device can be operated on the street but a Shared Mobility Device requires a drivers license.

Shared mobility devices refer to trans portation services that allow users to share vehicles, bicycles, or other mo

des of transport, such as the scooters and bicycles in the downtown area. Use this document as you may and contact law enforcement

\*\* = A valid driver's license is required for a shared mobility device but is not for a personal use device. Users of shared mobility devices must be at least 18. It is unlawful to ride ANY gas-powered vehicle on trails in the city (LMC 12,08,025). Adults operating these various vehicles unlawfully may be cited for various traffic offenses. Adults who allow their children to unlawfully operate these vehicles can be cited for allowing an unauthorized person to operate a motor vehicle (60-491).
